The Michael E. Reed Class of 1975 Social Justice Professorship: We will endow a full professorship that will focus on the in-depth, interdisciplinary study of social diversity, and name it after our late classmate Mike Reed, the first Vice President of Diversity, Education, and Inclusion at Williams.

Class of 1975 Non-Traditional Student Scholarship Fund: The college is driving a significant rise in students from non-traditional backgrounds: military veterans, community college transfers, students coming from the work force or later in life.

The Class of 1975 Scholarship Fund: By continuing to make donations to our 25th Reunion Gift, we fully support two Williams students every year, and our scholarship fund has provided financial support for 40 students.

How can I make a gift to the Alumni Fund AND the Class of 1975 50th Reunion Funds?

To donate by credit card, visit **give2.williams.edu/1975** and you may use the "Designation" drop down menu to split one gift transaction between two or more gift purposes.

If you prefer to give by check, please make it payable to "Williams College," note the designation(s) in the memo line, and mail to Williams College, 50th Reunion Program, 75 Park Street, Williamstown, MA 01267.

Can I pledge to the Class of 1975 50th Reunion Fund or the Alumni Fund? How do I pledge?

Yes, we encourage you to spread your commitment out by making pledges to the '75 Fund and/or the Alumni Fund over up to five years. This is a particularly wonderful way to demonstrate your continued commitment to the college. The full amount of the pledge counts toward the Total 50th Class Gift.

How can I give from my IRA?

A popular and often highly tax-advantaged way to make a 50th Reunion gift is via an IRA. An IRA qualified charitable distribution (QCD) allows individuals age 70 ½ and older to make outright direct transfers of up to \$100,000 per year from traditional individual retirement accounts to qualified charities without having to count the transfers as income for federal tax purposes. Since no tax is incurred on the withdrawal, gifts do not qualify for a charitable deduction, but may be counted toward an individual's required minimum distribution (RMD) for those who have one. Retirement assets in 401(k), 403(b), SEP, or SIMPLE plans do not qualify, but may be rolled into a new or existing IRA and transferred to the charity. In addition, as part of your QCD, you can use your IRA to make a onetime life income gift up to \$50,000. Visit giftplanning. williams.edu/qcd for gift parameters and further instructions to share with vour IRA administrator.

What is a planned gift? How do they count toward our Total 50th Class Gift total?

Planned gifts are those made as part of your overall financial and/or estate planning. There are many ways to structure a gift to Williams and a wide variety of assets you can use. Planned gifts can count toward the Total 50th Class Gift while, in many cases, providing tax advantages and even an income stream.

What gift types can be used to support the Total 50th Class Gift?

Outright gifts can be made using a variety of assets, including:

- Cash (check, credit card, or wire transfer)
- Appreciated securities
- IRA (Qualified Charitable Distribution)
- Donor Advised Fund grants
- Life insurance policies
- Unique assets like art and real estate
- Gifts influenced by relatives, foundations, and corporations
- Matching gifts from an employer or a foundation

How do gifts to the annual Alumni Fund count in our Total 50th Class Gift?

All Alumni Fund gifts made since our 40th Reunion count toward our Total 50th Class Gift. However, they do NOT count toward the Class of 1975 50th Reunion Fund totals, as they serve a different purpose at Williams.

Can I support a priority at Williams that is not one of our 50th Reunion Fund purposes? Will that count to our Total 50th Class Gift?
